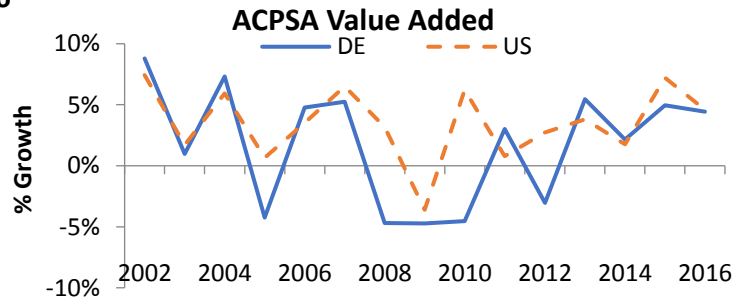

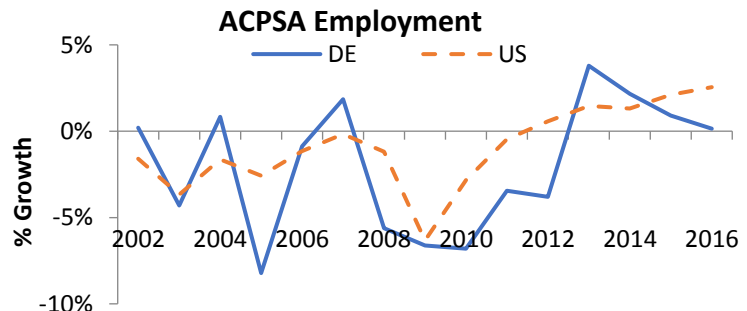

Trends in Arts and Cultural Production: 2015-2016

In 2016, Delaware ranked 50th among all states in ACPSA value added, and 20th among all states in ACPSA value added growth. Since 2015, ACPSA value added has grown 4.42 percent in Delaware, compared with an increase of 4.59 percent for the U.S.

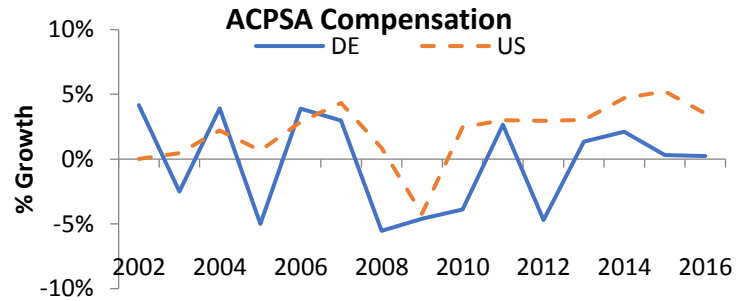


In 2016, Delaware ranked 51st among all states in ACPSA employment, and 38th among all states in ACPSA employment growth. Since 2015, ACPSA employment has grown 0.15 percent in Delaware, compared with an increase of 2.55 percent for the U.S.

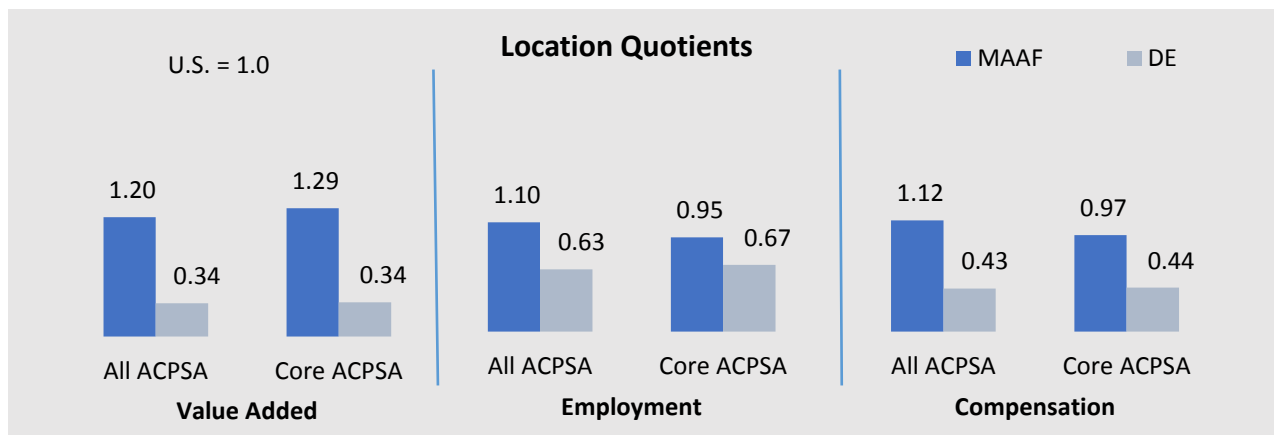
In 2016, Delaware ranked 51st among all states in ACPSA compensation, and 46th among all states in ACPSA compensation growth. Since 2015, ACPSA compensation has grown 0.24 percent in Delaware, compared with an increase of 3.52 percent for the U.S.



Average compensation per wage-and-salary job in Delaware's ACPSA industries was \$53,961 in 2016, compared with \$67,562 for all salaried jobs in the state.

Location Quotients

- In 2016, ACPSA value added was 66 percent below the national average. By comparison, the LQ for arts-and-cultural production value added in all states belonging to the U.S. regional arts organization MAAF (of which Delaware is a member) was 1.2 or 20 percent above the national average.
- As for employment, in 2016 Delaware and MAAF had an LQ of 0.63 and 1.1 respectively.
- And for compensation, in 2016 Delaware and MAAF had an LQ of 0.43 and 1.12 respectively.



Definitions

ACPSA Value Added consists of the gross output of an industry less its intermediate inputs; the contribution of an industry to gross domestic product (GDP).

ACPSA employment consists of all wage-and-salary jobs where the workers are engaged in the production of ACPSA goods and services.

ACPSA compensation consists of the remuneration (including wages and salaries, as well as benefits such as employer contributions to pension and health funds) payable to employees in return for their ACPSA work during a given year.

Core ACPSA industries are originators of ideas and content associated with the creation of arts and culture. "Supporting" industries produce and disseminate arts and cultural commodities.

Location quotients (LQ) measure an industry's regional concentration of employment or compensation relative to the U.S. industry's share. For example, an employment LQ of 1.2 indicates that the state's employment in the industry is 20 percent greater than the industry's national employment share. An employment LQ of 0.8 indicates that the state's employment in the industry is 20 percent below the industry's national employment share.

Arts Regions, for the purpose of this brief, are defined by the geography groupings for the nation's six Regional Arts Organizations (RAOs). RAOs are nonprofit organizations that partner with their constituent State Arts Agencies and with the National Endowment for the Arts on planning and program delivery.

Mid Atlantic Arts Foundation (MAAF) contains the states (DE, DC, MD, NJ, NY, PA, VA, WV).
